The firm has a vast practice of obtaining transaction approvals from the Kazakhstan antimonopoly agencies, applying for the state's waiver of alienated subsoil use rights acquisition, obtaining currency operation permitting documents from the National Bank of the Republic of Kazakhstan, etc.

AEQUITAS lawyers regularly advise on licensing legislation matters and provide services that involve filing license applications with competent authorities.

Of late, AEQUITAS has been largely advising on matters relating to the application of the Eurasian Economic Union (EAEU) supranational legislations.

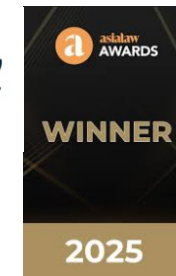

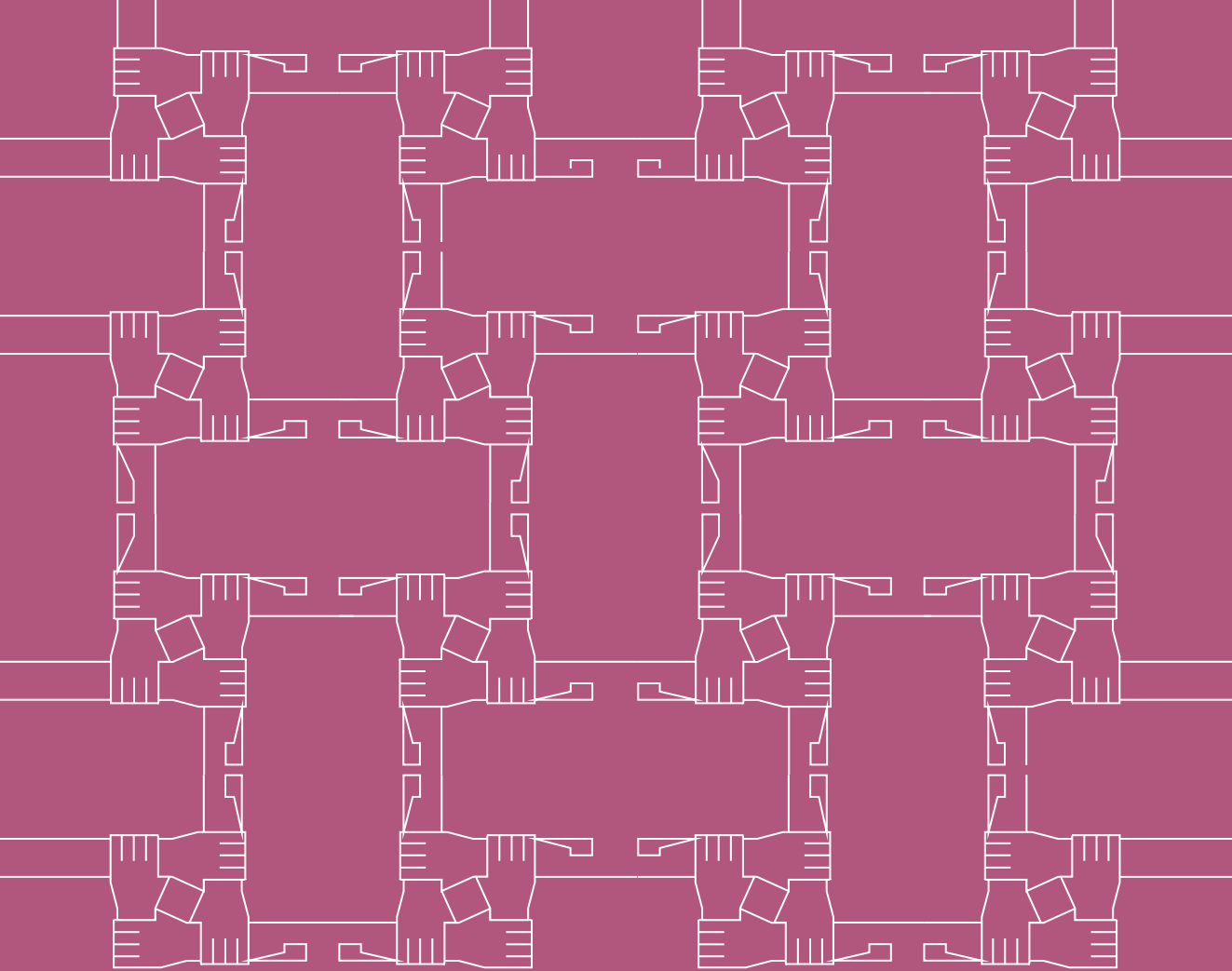
