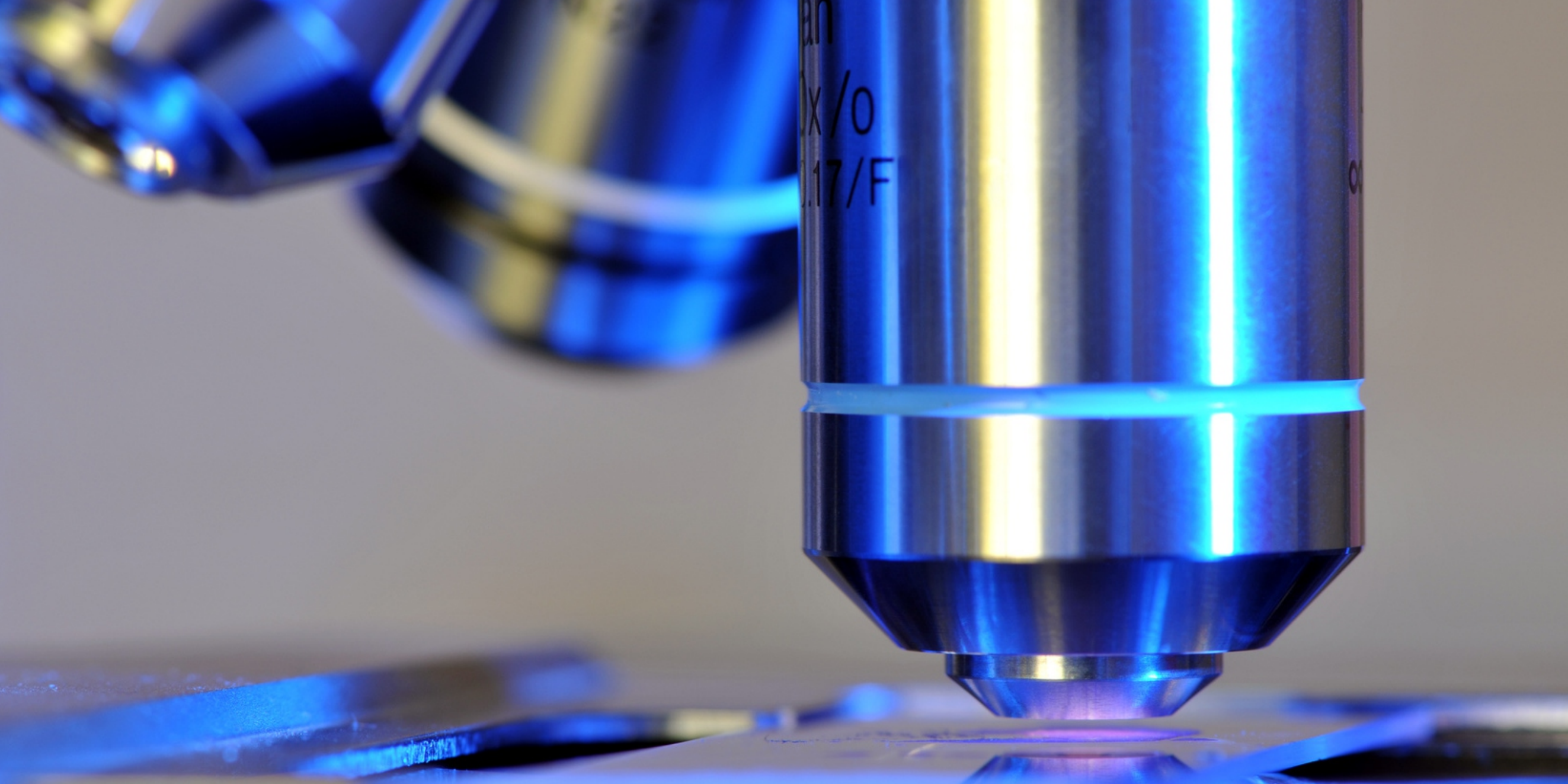

All-round legal support to Sanofi Aventis LLP, a subsidiary of Sanofi (France), the world's leading pharmaceutical company, including: advice regarding medicines advertising issues; different marketing actions conducted by medical professionals; regulation of online pharmacy activities in Kazakhstan; criminal and administrative liability and corruption offences in the field of medical and pharmaceutical activities; drafting of various service contracts; preparation of a set of mandatory documents for personal data legislation compliance; advice on antimonopoly regulation of the company relations with distributors; and analysis of legislation governing public procurement of medicines, medical products and medical equipment.

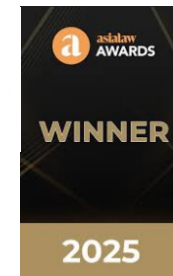

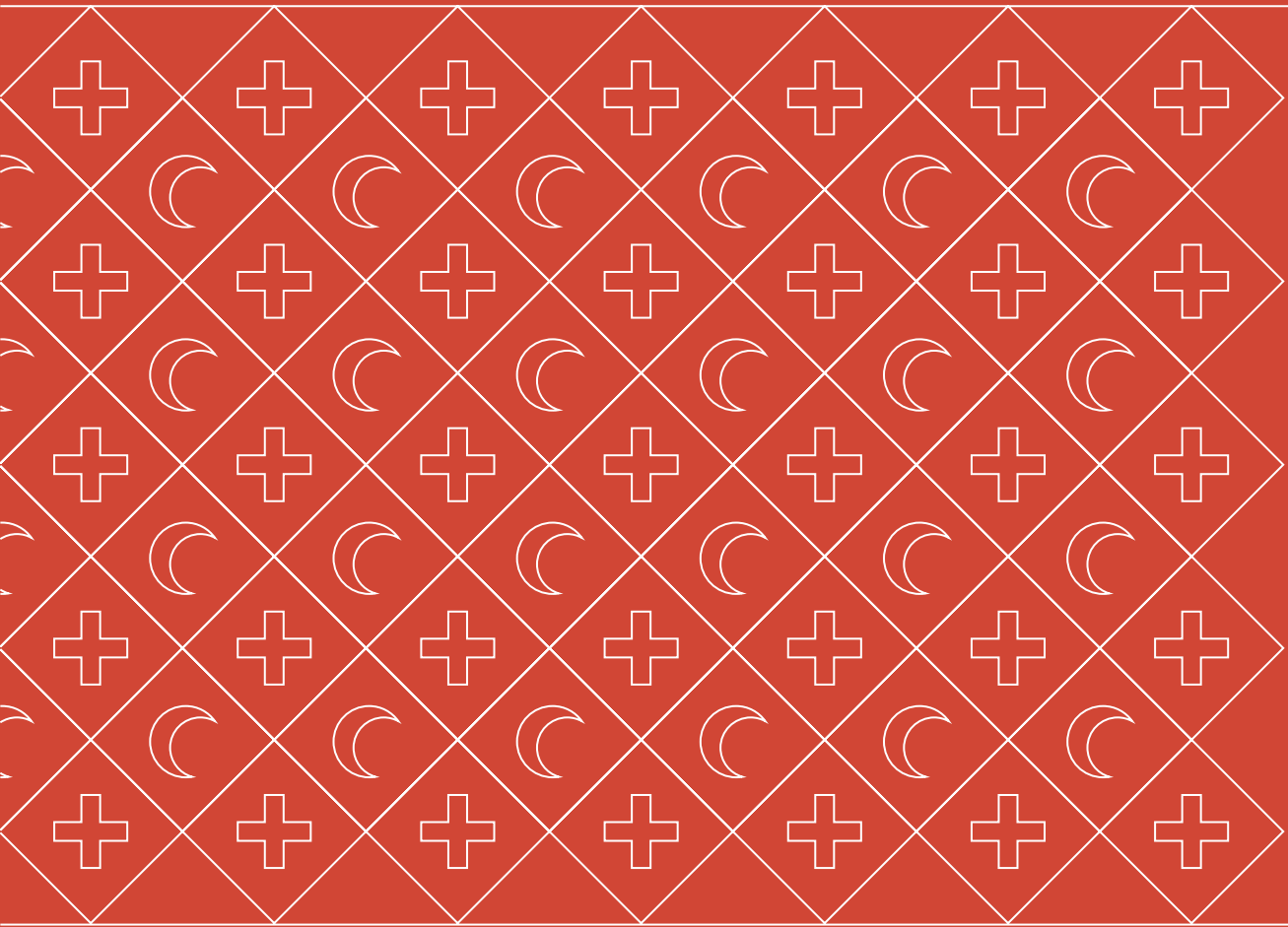
